

PARENTS VICTORIA CHAIR'S REPORT 2022

Which leads me to thank the incoming Minister for Education, the Honourable Natalie Hutchins, for her willingness to engage with our organisation so early in her tenure. We look forward to an equally respectful and productive relationship with her going forward.



CEO Report to PV2022 AGM

2022 is a significant year, as it marks 150 years of public education in Victoria.

Noting the Education Act 1872 (Vic) made our state the first Australian colony (and one of the first regions in the world) to offer free, secular, and compulsory education to children. The 1872 legislation required all children aged 6–15 years to attend school unless they had a reasonable excuse. If you haven't already, I urge all our members, supporters and followers to check out the Department 150th Anniversary website to access further historical information and stories about some of the schools that still exist today since those early beginnings. You may recall PV featured a story in Parent Voice (March) about our earlier women pioneers - https://www.vic.gov.au/celebrating-women-public-education#1930s

In keeping with this historical theme and reflecting on our last 12months, it seems timely to share what we've been doing in keeping with our organisation's mission and values in accordance with our strategy.

Since our beginnings in 1925 our organisation continues to strive to input and influence policy and practices in state education. With a State Election under 8 weeks away from writing this report and 4 weeks away from our AGM, our organisation continues to work in a 'non party-political' manner. You will see with our 2022 State Election asks, we seek commitments from all political candidates to put public education first with the public purse!

The objectives of the organisation in the early years were to establish a bond of union between Mothers Clubs (now Parent Clubs/Associations) of various schools; to confer questions of common interest and to advance the scholars (students) of Victorian Schools. Today PV offers FREE membership to all Victorian State Schools, those with a fully constituted club are deemed full members and those not constituted deemed general members. PV promotes and facilitates opportunity for parents to contribute their views and remain informed about state education reforms and resources. PV continues to prioritise students in state education in everything we do, in their best interest.

Reflecting on the issues raised in the 1930's by our predecessors, there still remains some common recurring themes, challenges and ongoing objectives. These include cost of schooling (known today as parent payments); a pursuit for free education from kindergarten to University; health initiatives like dental care (today we have Smiling Squad; Drs in Secondary Schools and Mental Health Practitioners); to raise the school leaving age to 15years (school is now compulsory to 17 years); opposition from Headmasters to the formation of Mothers Clubs (this one is the most disappointing - today we still have some Primary and Secondary School leaders who actively discourage some of our Parent Clubs to be constituted in accordance with the DET Secretary's model constitution!). In the past there was a lack of cooperation of School Committee's with the control of funds raised by Mothers' Clubs (now School Councils) – there remains an expectation for Parents' Clubs to fundraise and for School Councils to have the final decision on where that money is expended. PV continues to remind all schools to work in partnership with parents as they are the volunteers providing loads of good-will to the school. Volunteering has been hugely impacted over the last 3 years so we urge schools to rethink how they engage and support families to do better together for the future.

PV had hoped to do a series of road trips in Victoria this year but with Covid restrictions and schools being so overwhelmed with their own workforce shortages and daily demands, we parked that plan for 2023! Virtual meetings, briefings, webinars, case conferences and consultations with DET, Schools, Parent Clubs, parents and other stakeholders – these tasks have been on steroids this year. So, there is no excuse not to connect, it's just a matter of time and getting it into the PV calendar.

PV have done numerous submissions to state government and the DET -predominantly in the senior secondary pathway reform and mental health and wellbeing space. The most significant piece of work this year, following on from the enacting of a new School Protections Bill in 2021, was the Ministerial Guidelines for the NEW School Community Safety Orders implemented in Term 3 this year - https://www.vic.gov.au/school-community-safety-orders-ministerial-guidelines-templates

All this work could not be possible without the support and guidance of our wonderful volunteer PV Board team – Sharron, Trish, Tooba, Raelene and Paul and especially my hard working operational colleagues Leanne and Alan. Not for profit community organisations have done it tough the last few years and it's the commitment and loyalty of the PV people that make this happen – we continue to strive to be a "we culture" vs "me culture" putting others first in all that we do.



The 2022 calendar year sees Parents Victoria (PV) in the second year of our three-year Common Funding Agreement (CFA) with the Victorian Department of Education.

As reported in the 2021 Treasurer's report, PV's work tasks are guided by our CFA Accountability Work Plan core activities which are:- Parent Engagement; Responsive Complaints; Consultation and Advice. However, at the same time PV is versatile and responsive in order to support our Mission that the educational journey for every student in a state government school is holistically supported and achieved in partnership with parents, schools and Government.


Comments to the Profit and Loss Statement

- Contractor Payments. Includes PV's three contracted operations staff.
- Club Membership and Individual Membership. PV's 2021 updated constitution no longer includes the
 requirement for a membership cost to join PV. Individual Membership is also no longer an option. Parent
 Clubs, schools and parents with a child at a Victorian government school can join PV. Friend of Parents Victoria
 membership is still available.
- Annual Conference. PV's conferences are conducted in the second half of the calendar year and while both the 2020 and 2021 conferences were delivered online, costs to secure our valued speakers from year to year, varies. Conference costs generally were well down on budget, due to the online delivery versus the cost to present an in-person event.
- ACSSO. PV is the Victorian State Affiliate with the National organisation Australian Council of State School
 Organisations. Membership fees to the State Affiliate organisations were heavily subsidised by ACSSO for this year
 only.
- Executive Leadership Weekend. This meeting is an important part of the PV calendar where the Board and Operations staff come together at the beginning of each calendar year to set plans and priorities for the year ahead. PV appreciates the generosity of our volunteer Board Members to allocate a full weekend to this task.
- Projects Parent Workshops. PV partnered with Dr Debbie Pushor to offer a limited number of Victorian government school families the opportunity to register for a COOL (Chapters of Our Lives) family memoir project.
- Projects RbE. Creation of logo branding for the Relationship based Education (RbE) work which PV does in partnership with John Hendry OAM.
- Promotions. PV updated and refreshed our organisation promotional brochure.
- Subscriptions. This amount includes annual payment for PV's customer relations management system to receive communications under our Responsive Complaints work.
- Rent. PV secured two years (2021 and 2022) without an increase.

AUSTRALIAN COUNCIL OF STATE SCHOOL ORGANISATIONS (ACSSO) Member Report

On a National Platform, the year started tough for many schools as variants of COVID kept popping up in different states which meant that some schools were unable to revert to on-site learning because of the extensive staff shortages. On a more recent news, meetings have been held at various levels to address the growing shortage of teachers across the country. ACSSO has expressed interest to be involved in discussions.

The focus of expectations from the Government had always been mental health and wellbeing along with equitable funding model. Leading into the federal elections ACSSO reached out to several parties and asked them to join in a series of webinars to discuss their education policies. There was also a call of questions from the public so that their concerns could be raised during the webinars.

ACSSO worked closely with Life Skills Group during the National Check-In Week to promote emotional wellbeing resource that provided information about student's well-being on a daily basis.

ACSSO conducted a survey to gather information about the concerns of families and school staff. Some of the key issues that came forward were

- Support for student wellbeing and connectedness to school
- Support for students with additional needs
- · Recognition of authentic family engagement

ACSSO is completing 75 years of operating as a National Peak body for parents of Australia. The National Conference to be held in Canberra in November is expected to bring experts and speakers from around Australia who will be presenting the latest education happenings in Australia.

ACSSO is also looking up to set a New Online Communities platform that is set to launch at the conference. The aim of the platform is to facilitate discussions between interested individuals and groups across the nation including parents and families.

1. Summary of Significant Accounting Policies

(a) Basis of Preparation

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act (*) *. The committee has determined that the association is not a reporting entity.

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

(b) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, other short term highly liquid investments with original maturities of three months or less.

(c) **Employee Benefits**

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits have been measured at the amounts expected to be paid when the liability is settled, plus related on-costs.

(d) **Property, Plant and Equipment**

Property, plant and equipment are carried at cost, independent or committees' valuation. All assets excluding freehold land, are depreciated over their useful lives to the association.

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

(e) Revenue and Other Income

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the entity and specific criteria relating to the type of revenue as noted below, has been satisfied. Revenue is measured at the fair value of the consideration received or receivable and is presented net of returns, discounts and rebates.

All revenue is stated net of the amount of goods and services tax (GST).

Sale of Goods

Revenue is recognised on transfer of goods to the customer as this is deemed to be the point in time when risks and rewards are transferred and there is no longer any ownership or effective control over the goods.



Interest Revenue

Interest is recognised using the effective interest method.

Rendering of Services

Revenue in relation to rendering of services is recognised depends on whether the outcome of the services can be measured reliably. If this is the case then the stage of completion of the services is used to determine the appropriate level of revenue to be recognised in the period.

If the outcome cannot be reliably measured then revenue is recognised to the extent of expenses recognised that are recoverable.

Subscriptions

Revenue from the provision of membership subscriptions is recognised on a straight line basis over the financial year.

(f) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the statement of financial position.







Recipes for Great Schools

Parents Victoria Online Conference (Zoom webinar) – October 11, 2021 (Notes as taken by Parents Victoria)

The Parents Victoria (PV) Board took the decision to again present an online conference in 2021.

The conference theme was well received and the speakers definitely delivered.

Official Conference Opening – Hon. James Merlino, Deputy Premier, Minister for Education and Minister for Mental Health

Minister Merlino shared his recipe for great schools - responding that the pandemic has highlighted what makes schools great – **community and connection**. Minister Merlino thanked Parents Victoria for a strong year of advocacy and for invaluable wise council in another difficult school year and said that parents and schools have formed stronger connections. He added that generous proportions of wellbeing, equity and excellence are needed.

The Minister took questions from conference attendees.

Caring through Connection – how we build relationships, develop trust and safety, and support regulation for our children to thrive and grow. **Dr Elspeth Stephenson**, **Lecturer in Education**, **Professional Learning**, **Faculty of Education**, **University of Tasmania**.

Dr Stephenson gave a challenging and inspiring presentation on the impact of trauma on children's ability to learn, and what can be done about it. She said:

- Imagine a world where the cry of every child is met by a loving, compassionate adult
- •Diagnosis does not always relate to the trauma experienced (often there is no consideration of that horror)
- •It is important to share the understanding of the significance of the early years and trauma and how to work to enable the child to learn. A child is not emotionally well if they are not safe
- •Everyone who touches the life of a child can make a difference
- •Complex Trauma "The experience of multiple, chronic and prolonged, developmentally adverse traumatic events, most often of an interpersonal nature ...and early life onset" (van der Kolk, 2005, p.402)
- •Children are not wilfully disobedient. They are trying to tell you something from their behaviour. Behaviours are survival techniques.
- •Evidence is clear that regardless of adversity and age, if we respond we can make positive and significant impact
- •Stay calm no matter what. See the need behind the behaviour. Meet the need. Find a way.

Joan Kirner Award 2021

The Minister for Education, James Merlino announced via a pre-recorded video message that Parents Victoria advised the winner of this Award is - **all parents and carers of Victorian government school students** – in recognition of their incredible efforts to support children to learn from home over the past two years of the pandemic.

The Minister acknowledged that the late Joan Kirner would have whole-heartedly supported this well-deserved recognition, as does he.

Sharron Healy also agreed that Joan would have been very pleased with the spectacular job parents have done.

Collective Conversation on Consent

Debbie Ollis, Honorary Associate Professor, School of Education, Deakin University.

Session facilitator. Introduction and setting the scene.

Debbie informed that parents are primary educators in this space, they are a trusted source of information and that consent needs to be a collective conversation. There has been a great suite of resources developed over the last 30 years. Parents are the missing link in a whole-school approach. There needs to be a framework for parents.

Chanel Contos, Sexual assault activist, tutor and post graduate student.

Creating a culture where our children are safe (via pre-recorded video).

Home and school messages need to be noncontradictory. Language used to communicate with children is important. We need a **no-blame language** in order to encourage children to be open to having discussion. Discussion about pornography is necessary – from school and parents. Create open situations so that children can speak about this – can't afford these issues to be taboo or children won't speak up. Language at home when referring to sexual assault victims is important, as children are assessing whether they could come to their parents, if they needed to. Situations are harder for your child than they are for you – ask them what they need?

Chanel lobbies for consent to be taught in schools. Parents need to be in these conversations. But not everyone has involved parents.

Katrina Marson, Advocate for Relationships & Sexuality Education.

Comprehensive relationships and sexuality education.

Katrina informed that parents play a critical role in teaching sexuality education. Rates of sexual violence are not an unchangeable constant and the source of sexual violence is something we can change. We have to teach children it is unfair not to teach them. Students comment "we wished we had learned this at school."

They have already needed the lesson and they haven't had it! Learning about healthy intimate relationships and what they look like. Respecting feelings. Children need to start learning at a young age.

Standards need to be carefully articulated – e.g. not just as "free from violent" but "far from violent". Inconsistent messaging can work to undo the benefits of lessons. Some parents worry that lessons at school will exclude the parents. Overseas it is recognised that this is a partnership between home, school and community. Some parents feel this information is more appropriate to be given at home and not school. Unfortunately, there would be many parents who would not give the lesson at home. It's helpful for students to learn with their peers. Kids need **everyone** to stand up.

Sharron Healy recounted that we need to do better at home and in the classroom regarding the consent discussion; parents would probably love to have resources to assist the content delivery; PV can always have discussions with DET about the funding. Sharron acknowledged Debbie's comment that parents are the missing link and added that PV finds that in much of our work. There is work happening at both State and National level for initial teacher educators about **family engagement!** Sharron again thanked conference delegates for attending and formally closed the 2021 conference.
